#### Description

The LGU - Mariveles, through the Budget of the Contract Approved by the Sanggunian of 2019 intends to apply the sum of Five Hundred Thousand Pesos (Php 500,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Mutya ng Mariveles 2020 Event. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The LGU – Mariveles now invites bids for aforementioned project. Delivery of the goods and services is required within 25 days after the receipt of Notice to Proceed. Bidders should have completed, within 3 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail”

criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Interested bidders may obtain further information from Office of the Bids and Awards Committee, Municipal Hall Compound Mariveles, Bataan and inspect the Bidding Documents at the address given below during 8:00 -5:00pm, Monday to Friday.

A complete set of Bidding Documents may be acquired by interested Bidders starting on January 13, 2020.

The LGU - Mariveles will hold a Pre-Bid Conference on January 17, 2020, 10:00am at Office of the Bids and Awards Committee Mariveles Hall Compound Mariveles, Bataan which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before 12nn January 29, 2020 using the wall clock in that Office as the official time of the LGU – Mariveles BAC Office. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on 2:00pm, January 29, 2020 at the Office of the Bids and Awards Committee Municipal Hall Compound Mariveles, Bataan. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The LGU - Mariveles reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
