The LGU- Mariveles, through the Budget of the Contract Approved by the Sanggunian of 2020 intends to apply the sum of FOUR HUNDRED THOUSAND and 00/100 Pesos only(Php 400,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the, RENTAL OF MOBILE LIGHTS AND SOUND SYSTEM (

WITH LED TV MONITOR) TO BE USED FOR THE CELEBRATION OF TOWN FIESTA in Mariveles, Bataan. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The LGU- Mariveles now invites bids for the aforementioned project. Mobilization of project is required within immediately after the receipt of Notice to Proceed. Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorship, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from Office of the Municipal Engineer, Municipal Hall Compound Mariveles, Bataan and inspect the Bidding Documents at the address given below during 8:00am – 5:00pm, Monday to Friday.

A complete set of Bidding Documents will be available for interested bidders starting January 11, 2020 at the OFFICE OF THE BAC The LGU – Mariveles will hold a Pre-Bid Conference on January 17, 2020, 10:00 am at the Office of the BIDS AND AWARDS COMMITTEE Mariveles Hall Compound Mariveles, Bataan which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the Office of the Municipal Engineer Municipal Hall Compound Mariveles, Bataan on or before 12 nn January 29, 2020 using the biometric clock in the Office as the official time of the LGU-Mariveles BAC office. All prospective bidders are advised to strictly observe the official time of submission. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be at 2:00 pm on January 29, 2020 at the Office of the BAC Mariveles Hall Compound Mariveles, Bataan. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the above-cited address. Late bids shall not be accepted.

The LGU – Mariveles reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
